## **TVA Membership Eligibility**

The Membership Shall Consists of :

**Clause : 5.1 in Bye - laws, Person should be above 18 years of age & should have a degree / diploma in engineering / Architecture / under section 34AB registration (wealth tax act 1957) / ibbi registration / have passed Section - A and Section - B examination of The Institution of Engineers (India), and fulfill basic requirement of qualification.**

### **Eligibility for Enrolment as Students**

Every candidate for selection as a Student Member Pursuing :-

must not be less than 18 years for Diploma in Engineering / Degree in Engineering with 20 years of age.

One time Student membership fee is Rs. 1200/-

### **Eligibility for Enrolment as Licentiate**

Every candidate for Selection as a Licentiate

(i) must not be less than 18 years of age ;

(ii) must be a **AS PER THE CLAUSE No. 5.1** and must have passed such examination as the Council may accept as equivalent Licentiate membership.

One time Licentiate Membership fee is Rs. 2,500/-

### **Eligibility for Enrolment of Associates**

Every candidate for Selection as a Associate

(i) Age - 18 years ; and Dip with 5 years / degree with 3 years experience **AS PER THE CLAUSE OF 5.1**

(ii) Associate membership fee is Rs. 2500/-

(iii) The Licentiate Members shall upgrade to Associate Membership within 5½ yrs from the date of obtaining the membership. Else, the Council may take an appropriate decision. The upgradation fee is Rs. 1,250/-.

### **Eligibility for Enrolment of Fellow & Life membership**

Every candidate for Selection as a Fellow Member

(i) Every fellow membership, Diploma with 8 years / Degree with 5 years / Masters Degree with 2 yrs experience **AS PER THE CLAUSE OF 5.1** on admission shall pay Rs. 5000 (Rupees One Thousand only) as admission fee which shall not be refunded in any case and Rs. 1500/- (Fifteen hundred Only) to be paid by member for renewal of their yearly membership as subscription.

**OR**

**Life Membership Fees of Rs. 20000/- (Twenty Thousand Only) as one time payment Optional.**

The Associate Members shall upgrade to Fellow Membership within 3½ yrs from the date of obtaining the membership. Else, the Council may take appropriate decision. The up gradation fee is Rs. 4,000/-
